#### 1. Introduction

# CDBG-CV Prevent, prepare for and respond to COVID-19.

The Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed by President Trump on March 27, 2020 to respond to the growing effects of the Novel Coronavirus, also referred to as COVID-19. The US Department of Housing and Urban Development (HUD) will be allocating \$2 billion in the initial phase of funding under the CARES Act to Community Development Block Grant (CDBG) grantees. Grantees may use these funds, also referred to as CDBG-CV funds, for a range of activities to prevent, prepare for, and respond to the coronavirus.

HUD's distribution plan for the supplemental funding includes multiple phases. This is the initial phase that allows for quick access to funding to address the immediate crisis resulting from this historical health pandemic. The later phases will support post-pandemic community recovery. The 2019-2020 Annual Action Plan will be amended to add the additional funding from this initial phase.

As permitted in the CARES Act, HUD has allowed for the following waivers to the typical CDBG regulations due to the urgency of utilizing these funds:

- The City is not required to update the Needs Analysis sections in 2015-2020 Consolidated Plan and the 2019-2020 Annual Action Plan.
- The 30-day public comment period has been shortened to a minimum of 5 days.
- The 15% Public Service cap is not a requirement.

The City of Pittsburg (City) is submitting a Substantial Amendment for the 2019-2020 Annual Action Plan (Substantial Amendment) to include the plan for expending CDBG-CV funds.

### 2. Summarize the objectives and outcomes identified in the Plan

CDBG-CV funds will be utilized for a range of activities to prevent, prepare for, and respond to the coronavirus.
