NOTICE IS HEREBY GIVEN that the **CITY COUNCIL of the City of Pittsburg** will, following the close of the public hearing on January 19, 2021, conduct a continued discussion on:

Concerning the following matter:

Introduction and Waive First Reading of an Ordinance Establishing a Limited Overlay District and Overlay Plan for a 1.03-Acre Site Located at 1416 Bobo Court and Adoption of a City Council Resolution Approving Commercial Cannabis Permits and an Operating Agreement Between the City and E7 Pittsburg LLC ("Element 7"), AP-19-1435 and AP-19-1454.

This is request for City Council approval of a zoning amendment establishing a limited overlay district to allow a 'Food and Drug Processing' use with limitations exclusively for commercial cannabis businesses as well as consideration of a request for City Council approval of 1) four commercial cannabis permits to allow for the use of cannabis within medical and nonmedical consumer product manufacturing; and 2) an operating agreement between the City and Element 7. The project site is located at 1416 Bobo Court in the CS (Service Commercial) District (Assessor's Parcel No. 088-570-009).

On January 19, 2021, the City Council held a public hearing on this item, at which time oral and written testimony was heard. Following the close of the public hearing, the City Council continued the item in order to allow for discussion and deliberation.

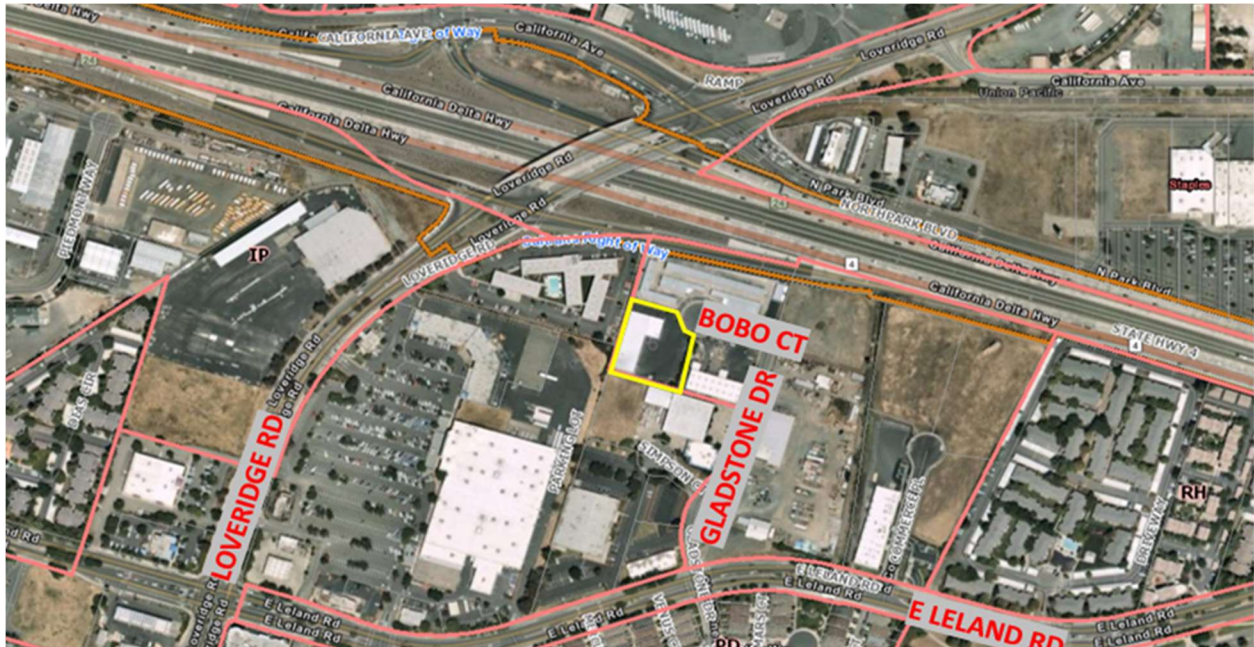
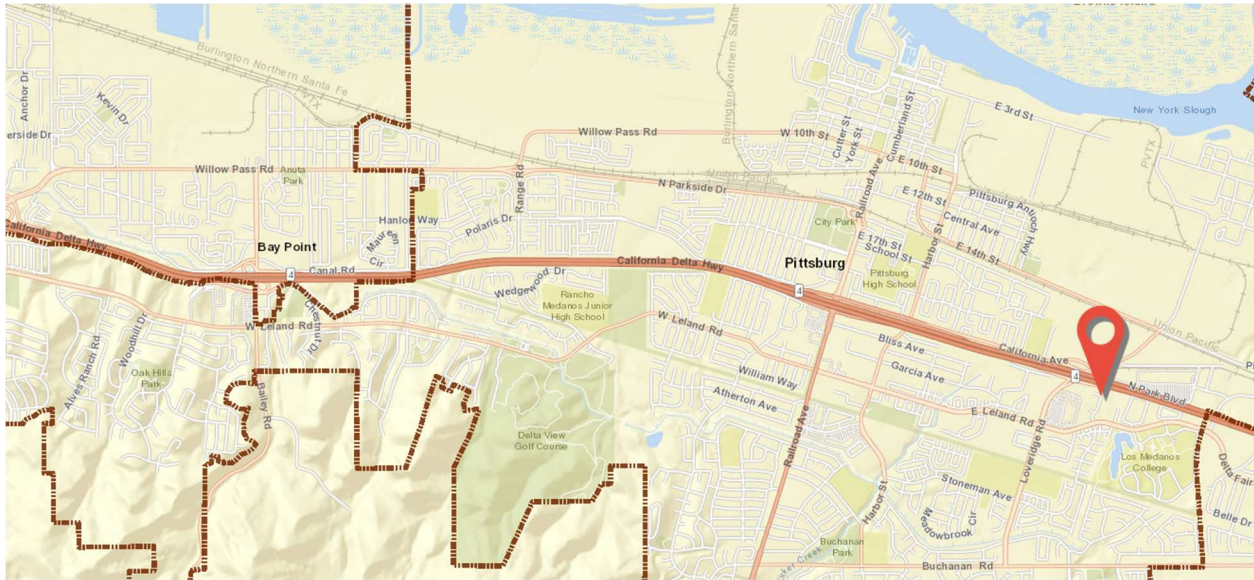
