ALL PROSPECTIVE BIDDERS are hereby notified that changes to the bidding documents for Contract 2021-14; GHAD Bi-Annual Weed Abatement are to be made as described hereinafter.

ITEM 1 - Page 1 in the RFQ - Remove "NOTICE IS HEREBY GIVEN that sealed proposals for the work entitled: Contract No. 2021-14 Southwest Pittsburg Geological Hazard Abatement District Bi-Annual Weed Abatement will be received by the City of Pittsburg at the front of City Hall, 65 Civic Avenue, Pittsburg, California (first floor) until 2:00 p.m. on September 29, 2021 at which time they will be opened and read aloud." and replace with the following:

## NOTICE IS HEREBY GIVEN

that sealed proposals for the work entitled: Contract No. 2021-14 Southwest Pittsburg Geological Hazard Abatement District Bi-Annual Weed Abatement will be received by the City of Pittsburg at the front of City Hall, 65 Civic Avenue, Pittsburg, California (first floor) until 2:00 p.m. on October 4, 2021 at which time they will be opened and read aloud."

ITEM 2 - Page 1 in the RFQ - Remove "Bids must be received no later than September 29, 2021at 2:00 P.M." and replace with the following:

Bids must be received no later than October 4, 2021 at 2:00 P.M.

ITEM 3 - Page 10 of ITEM 13 in Addendum No. 1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to remove non-native invasive plant species assigned to parcel 091-050-061 it is estimated that the work will be completed in 6 days." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours in a day to remove non-native invasive plant species assigned to parcel 091-050-061 it is estimated that the work will be completed in 6 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 12 days during four (4) visits in two (2) years.

ITEM 4 - Page 10 of ITEM 14 in Addendum No. 1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-180-003 it is estimated that the work will be completed in 3 days." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-180-003 it is estimated that the work will be completed in 3 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 6 days during four (4) visits in two (2) years.

ITEM 5 - Page 10 of ITEM 15 in Addendum No. 1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-160-063 it is estimated that the work will be completed in 2 days." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-190-045 it is estimated that the work will be completed in 2 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 4 days during four (4) visits in two (2) years.

ITEM 7 - Page 11 of ITEM 17 in Addendum No. 1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-050-059 it is estimated that the work will be completed in 3 days." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-050-059 it is estimated that the work will be completed in 3 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 6 days during four (4) visits in two (2) years.

ITEM 8 - Page 11 of ITEM 18 in Addendum No. 1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-$050-040$ it is estimated that the work will be completed in 1 day." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-050-041 it is estimated that the work will be completed in 1 day during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 2 days during four (4) visits in two (2) years.

ITEM 9 - Page 11 of ITEM 19 in Addendum No. 1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-050-041 it is estimated that the work will be completed in 1 day." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities and remove non-native invasive plant species assigned to parcel 091-050-040 it is estimated that the work will be completed in 1 day during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 2 days during four (4) visits in two (2) years.

Assume that if a two (2) man crew works eight (8) hours a day to remove non-native invasive plant species assigned to parcel 091-050-055 it is estimated that the work will be completed in 10 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 20 days during four (4) visits in two (2) years.

Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 8 days during four (4) visits in two (2) years.

Assume that if a two (2) man crew works eight (8) hours a day to complete weed abatement activities assigned to parcel 093-460-009 it is estimated that the work will be completed in 14 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 28 days during four (4) visits in two (2) years.

Assume that if a two (2) man crew works eight (8) hours a day to complete provide landscape maintenance assigned to the median island near Tomales Bay Dr. it is estimated that the work will be completed in 2 days during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 4 days during four (4) visits in two (2) years.

ITEM 17 - Page 16 of ITEM 27 in Addendum No.1 - Remove "Assume that if a two (2) man crew works eight (8) hours a day to complete landscape maintenance assigned to the median island near Alves Ranch Rd. it is estimated that the work will be completed in 1 day." and replace with the following:

Assume that if a two (2) man crew works eight (8) hours a day to complete provide landscape maintenance assigned to the median island near Alves Ranch Rd. it is estimated that the work will be completed in 1 day during two (2) visits in a year. Taking into consideration that the project is to be entirely completed four (4) times between October 1, 2021, and June 14, 2023, it is estimated that the work will be completed in 2 days during four (4) visits in two (2) years.

ITEM 18 - Page 17 \& 18 of Bid Worksheet in Addendum No. 1 - Remove "Bid Worksheet" and replace with the following:
