What can I do if I have comments on the project?

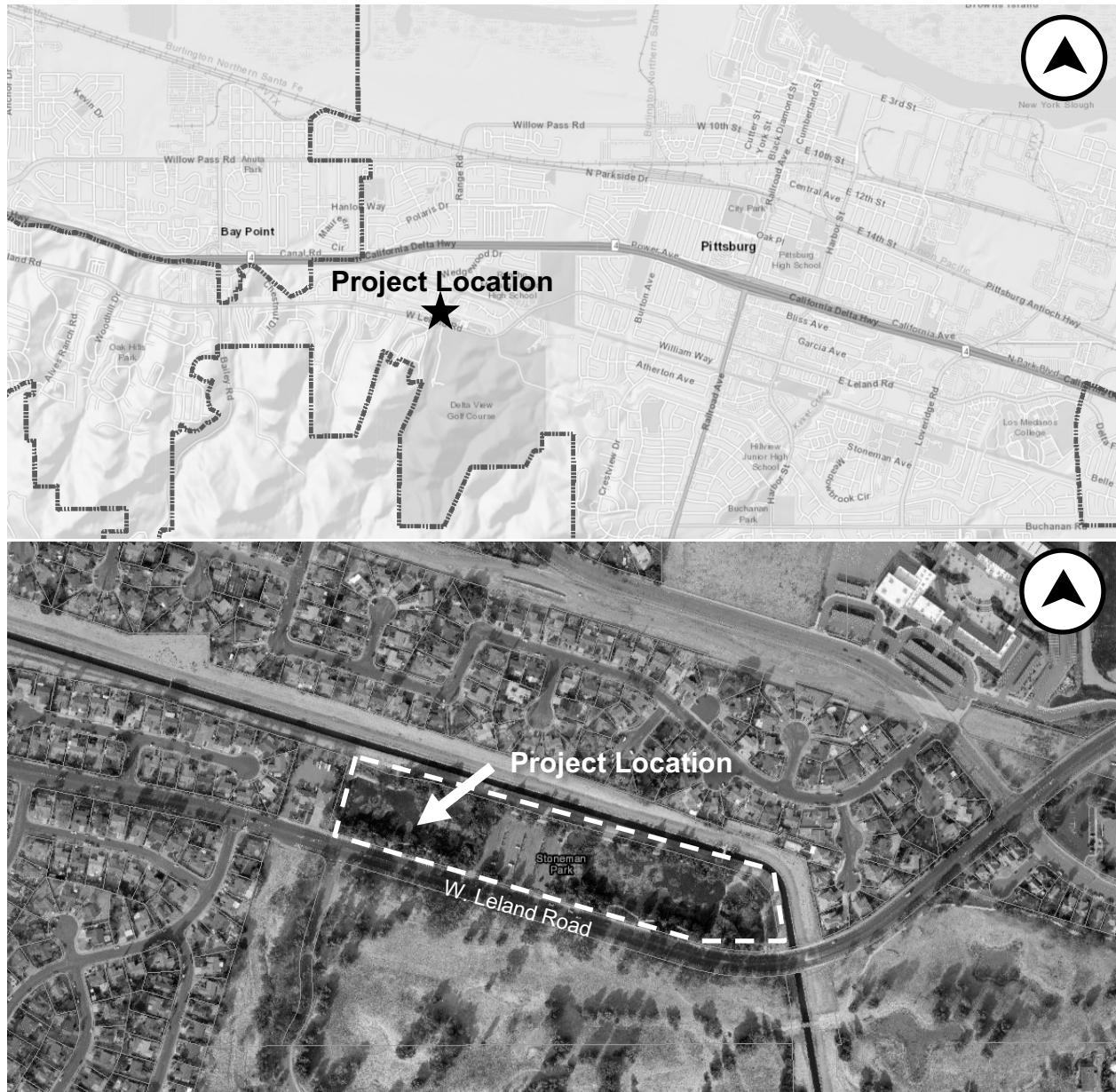
