In our experience, many ERP systems on the market today do not have the same level of robust functionality as other solutions that have been specifically developed to support a process like Budget development (Operating, Capital, Workforce Planning, Budget Book Publication, Reporting, etc), for example.	As mentioned in the section A.5.1 of the RFP document, City would be looking for proposals which are overall fit and in the best interest of the City. The section A.5.1 also encourages to submit joint bids, if all the RFP requirements are not met with the products and services of the responding firm.

As clearly brought out in RFP, City expects this project to be executed mainly in onsite mode.
